As you read these words spoken by Our Lady to the children of Fatima, I hope you will prayerfully consider joining me on this pilgrimage marking the centennial of the apparitions in Fatima.

First apparition of Our Lady

"I came to ask you to come here for six consecutive months, on the thirteenth day, at this same hour. I will tell you later who I am and what I want. And I shall return here again a seventh time."

Second apparition of Our Lady

"I wish you to come here the 13th of next month; that you say the Rosary every day, and that you learn to read. In succeeding months I will tell you what else I want."

Third apparition of Our Lady

"When you recite the Rosary, say at the end of each decade: Oh My Jesus, forgive us our sins, save us from the fires of hell, and lead all souls to Heaven, especially those in most need of Your Mercy."

Fourth apparition of Our Lady

"I Want you to continue to go to the Cova da Iria on the 13th, that you continue to say the Rosary every day. I, in the last month will make the miracle that all will believe."

Fifth apparition of Our Lady

"I Want you to come here on October 13 and that you continue to recite the Rosary to obtain the end of the war. In October the Lord, the sorrowful Lady, the Lady of Mt. Carmel, and St Joseph with the child Jesus, will also come to bless the world."

Sixth apparition of Our Lady

"I am the Lady of the Rosary, I desire here a chapel in my honor to be built, that people continue to recite the Rosary every day..."

Day 1 May 10, Wednesday: Depart USA

Depart Newark Liberty International Airport via United Airlines for the overnight flight to Lisbon, Portugal.

Dinner, breakfast and beverages will be served aloft. (D,B)

Day 2 May 11, Thursday: Arrival in Lisbon - Fatima

Arrive at Lisbon International Airport. Go through Passport Control, claim our luggage, and a Peter's Way tour manager will meet us upon our exit from Customs. Board our private coach bus and soon we will be on our way to Lisbon for an orientation tour of this beautiful Portuguese city. We will visit the Church of St. Anthony in Lisbon, where in 1195, St. Anthony of Padua, patron saint of Portugal, was born. **Celebrate Holy Mass at St. Anthony Shrine.** Continue to the Cathedral, housing the Saint's baptismal font. Then we will pass by the Belem Quarter, Belem Tower, 25 April Bridge, Discoveries Monument and St. Jerome's Monastery. Independent lunch.

En route to Fatima visit the town of Santarem. Take a short walk through narrow streets leading to the church of St. Stephen, where we will behold the Eucharistic Miracle known as the Holy Miracle of Santarem, a relic that's been kept here since 1269. View the Venerated Relic of the "Bleeding Host". Prayer and reflection in the shrine. Continue to Fatima, where the Blessed Mother appeared in 1917 to three simple shepherd children and exhorted mankind to pray for world peace. Check-in at Domus Pacis in Fatima. **After dinner, participate in the evening Eucharistic Procession.**

Dinner and overnight at Domus Pacis in Fatima. (D)
(Hotel arrangements by Franciscan University of Steubenville)

Day 3 May 12, Friday: Full Day in Fatima

Buffet breakfast at hotel. This morning, **celebrate Holy Mass.** Then, our guide will take us on a walking tour of the Shrine. In May 1917, Our Lady was seen several times by three shepherd children—Jacinta, Francisco and Lucia—at a place called Cova da Iria, where the Basilica now stands. Visit the tombs of the children and the Chapel of the Apparitions known as the Capelinha. Independent lunch. Then, we will visit Aljustrel, the hamlet where the three children lived and view their untouched homes. Visit Valinhos where Our Lady appeared after the children's return from prison. Following the Stations of the Cross along the Via Sacra (The Sacred Way), built by Hungarian refugees that culminates in the Chapel of Calvary, visit the Church where the children were baptized. The rest of the day will be free for private devotions. **Participate in the evening Eucharistic Procession.**

Dinner and overnight at Domus Pacis in Fatima. (B,D)

Day 4 May 13, Saturday: Full Feast day in Fatima

Buffet breakfast at hotel. Full day at Fatima to celebrate 100-year anniversary of Mary's appearance to children. **Participate in the evening Eucharistic Procession.**

Dinner and overnight at Domus Pacis in Fatima. (B,D)
(Hotel arrangements by Franciscan University of Steubenville)

Day 5 May 14, Sunday: Excursion to Bom Jesus

Buffet breakfast at hotel. This morning, leave Fatima and drive north to Bom Jesus. The first indication of a chapel over the hill dates from 1373. This chapel - dedicated to the Holy Cross - was rebuilt in the 15th and 16th centuries. In 1629 a pilgrimage church was built dedicated to the Bom Jesus (Good Jesus), with six chapels dedicated to the Passion of Christ. The present Sanctuary started being built in 1722, under the patronage of the Archbishop of Braga, Rodrigo de Moura Telles. His coat of arms is seen over the gateway, in the beginning of the stairway. Under his direction the first stairway row, with chapels dedicated to the Via Crucis, were completed. Each chapel is decorated with terra cotta sculptures depicting the Passion of Christ. He also sponsored the next segment of stairways, which has a zigzag shape and is dedicated to the Five Senses. The senses: sight, smell, hearing, touch, taste are represented by different fountains. At the end of this stairway, a Baroque church was built around 1725 by architect Manuel Pinto Vilalobos. Independent lunch. On our return to Fatima, we will stop at Coimbra to visit the Carmelite Monastery where Sister Lucia, one of the three shepherd children, lived until her death in 2005. **Celebrate Holy Mass.** Late afternoon, return to Fatima.

After dinner, participate in the evening Eucharistic Procession. Dinner and overnight at Domus Pacis in Fatima. (B,D)

Day 6 May 15, Monday: Full Day in Fatima

Buffet breakfast at hotel. This morning, **celebrate Holy Mass.** Full day of retreat at the Shrine. **After dinner, participate in the evening Eucharistic Procession.**

Dinner and overnight at Domus Pacis in Fatima. (B,D)
(Hotel arrangements by Franciscan University of Steubenville)

Day 7 May 16, Tuesday: Return to the USA

After breakfast, we will be transferred to Lisbon International Airport for our return flight to the USA. Arrive in Newark early afternoon, overflowing with memories. (B)

Unexpected circumstances may cause changes to the outlined itinerary.

PAYMENT: Deposits and insurance payments will be accepted in the form of check, money order or credit card. The package pricing reflects a discount of \$100.00 per person for payments made entirely by personal check, money order or certified bank check. The package price is \$100 higher if paid by credit card. Peter's Way Tours reserves the right to increase package price or reduce services accordingly should there be an escalation in the Euro valuation over the U.S. Dollar in excess of 3% from print date. If final payment is not received by the balance deadline, Peter's Way Tours reserves the right to cancel your reservation. If for any reason payment is received within 21 days of departure, a charge for express mailing of final documents will apply. A \$50.00 late payment fee and possible increase in airfare may apply for late payments. Personal checks will not be accepted within 30 days of departure. If the bank has returned a personal check, a \$25.00 processing fee will apply and subsequent payments must be made in the form of money order, certified bank check or credit card.

CANCELLATIONS/REFUNDS: From the time your deposit is received up to 130 days prior to departure, there is a \$250.00 nonrefundable cancellation fee per person. From 129 to 100 days prior to departure, there is a \$350.00 nonrefundable cancellation fee per person. From 99 days prior to departure up to the day of departure, there is a nonrefundable cancellation fee of 100% of all payments made per person including departure taxes & fuel surcharges, single supplement, deviation fees, travel insurance payments and any other costs incurred. TRAVEL DOCUMENTS: All participants must have a valid passport. U.S. Passports must be valid for at least **three (3) months subsequent to return date**. Special entry requirements for non-U.S. citizens may apply. Please consult the appropriate Consulate for current requirements. It is solely the passenger's responsibility to ensure that all documents needed are completed and current. Peter's Way Tours will not be held responsible for lack of current and valid entry documents.

AIR TRANSPORTATION: Round trip from **Newark on United Airlines**. Flight itinerary and carrier may be subject to change. Departure taxes & fuel surcharges are estimated. They are determined solely by the airlines and are subject to increase prior to ticketing (approximately 30 days prior to departure).

AIRLINE SEATING: Under group airline reservations/contracts, the airlines will provide a block of seats for the group. Individual requests for seating preferences can only be made at time of check-in. Peter's Way cannot submit seating preferences as we cannot guarantee that any or all requests will be honored. If you require specific seating as a condition of your travel, it is suggested that you book your airfare individually and purchase the Land Only package. Upgrades to premium economy, business class, or first class may be available but oftentimes airlines will not allow the upgrades until time of ticketing (approximately 30 days prior to departure). Group reservations may not be accessible online for advance check-in/boarding passes/seat assignments. Airline guidelines vary. Please contact our office for specific details.

LAND ONLY PASSENGERS: Land Only packages do not include any portion of the group airfare. This includes any flights booked within the group itinerary. All airline tickets will be your responsibility to book independently. A passenger choosing the Land Only portion of the package (*Cost to be advised - please inquire*) must notify Peter's Way Tours, in writing, at least 100 days prior to departure or a penalty fee will be assessed. Please be advised, passenger(s) opting for the Land Only package or who are deviating from the group itinerary will be responsible for their own transfers to/from hotel/airport. However, if you arrive at the same time or earlier than your group, you are welcome to join the group on the bus. It is recommended that you purchase your air transportation only after you have been notified that the group has materialized. If you purchase your own air transportation and the group does not materialize or you cancel your package for any reason, Peter's Way Tours will not be held responsible for the cost of your airfare or other arrangements booked independently.

DEVIATIONS & ITINERARY CHANGES: Peter's Way Tours is pleased to assist clients with changes in itineraries. All deviation requests must be submitted in writing at least 90 days prior to departure. Deviation fee will apply plus an airline change fee per person. Your routing and dates requested will determine if a difference in airfare will also apply. Not all carriers permit routing changes and/or deviations from the group itinerary. Please contact our office for detailed information.

TRANSFERS AND PORTERAGE: Round-trip airport transfers are included for passengers who purchase the full air and land package. Porterage of one piece of luggage throughout your tour at hotels is also included.

ACCOMMODATIONS/SINGLE TRAVELERS: Price per person is based on two persons sharing twin bedded rooms with private facilities in hotels throughout your tour. Double bedded rooms for married couples are subject to availability and must be requested. Triple rooms may be requested for family or friends traveling together. Triple rooms usually are regular twin or double bedded rooms with a rollaway bed added. Single rooms are limited and cannot be guaranteed. For information, please inquire. If a single room must be assigned due to your roommate's cancellation, incompatibility or for any other reason

(even at the last moment or while on tour), we must charge you the tour's single supplement or pro-rated amount.

MEALS: Breakfast and dinner daily. Beverages (coffee, tea, mineral water) not included at set menu dinners.

GRATUITIES & SERVICE CHARGES: Gratuities to the tour manager/guide, and driver are not included in the package price and will be collected prior to departure. **\$70.00 will be added to each participant's final invoice to cover tips for the 7-Day Pilgrimage.** Other gratuities are usually handled individually. All service charges and local taxes as imposed by hotels are included in the program rate. Although service charges at the hotels are included, it is customary to leave 1,00 Euro per person for your waiter following dinner at the hotel and 1,00 Euro per person per day for the maid or housekeeper.
