DAY 1 Saturday, October 5: Depart USA

Depart Portland International Airport via United Airlines for our overnight flight to Edinburgh, Scotland. Complimentary dinner (D), breakfast (B), and beverages will be served on board.

DAY 2 Sunday, October 6: Arrive in Edinburgh | Tour of Rosslyn **Chapel**

This morning, arrive at Edinburgh Airport, proceed through Passport Control, claim our luggage, and meet a Peter's Way Tours tour manager upon our exit from Customs. Board our comfortable touring bus and we'll be on our way to visit Rosslyn Chapel. Rosslyn Chapel, originally named the Collegiate Chapel of St. Matthew, is a 15th-century church in the village of Roslin, seven miles from Edinburgh in Scotland. The chapel is famous both for its decorative art and its mysterious associations with the Knights Templar, the Holy Grail, and the Freemasons. Rosslyn Chapel's mysteries played a significant role in Dan Brown's 2003 novel, The Da Vinci Code. The chapel is now one of the most popular tourist destinations in Scotland. After our visit, continue for hotel check-in. Dinner and overnight at our hotel in Edinburgh.

DAY 3 Monday, October 7: St. Giles' Cathedral | Edinburgh Castle | Holyrood Palace

Full Scottish breakfast at our hotel. Today we will explore Edinburgh, travel along Princess Street and up the Mound. Walk along the Royal Mile, with its historic buildings, quaint shops, narrow lanes, hidden courtyards, and the home of John Knox. Visit St. Giles' Cathedral, named after St. Giles the Patron Saint of Lepers. Located in the Royal Mile, it dates back to 1120 and is famous for its stained-glass windows, magnificent organ, and exquisite "Thistle Chapel." It was here that Queen Elizabeth II's body lay in state for 24 hours on September 13, 2022. Lunchtime performance at St. Giles' Cathedral. Independent lunch.

This afternoon, visit Edinburgh Castle. No one is sure who first used the castle rock as a settlement, but it was long before the Romans came sailing up the Forth and landed at Cramond. The oldest building in all Edinburgh is to be found within the castle precincts. It is St. Margaret's Chapel, a tiny Norman building, which has been intact for more than 900 years. From the battlements, an immediate appreciation of the dramatic topography of Edinburgh can be seen, situated between sea and hills. The castle was the seat (and regular refuge) of Scottish Kings and the royal apartments include a tiny room in which Mary, Queen of Scots, gave birth to the boy who was to become King James VI of Scotland and James I of England upon the death of Queen Elizabeth in 1603. Edinburgh Castle is also the home of the "One O'Clock Gun." Continue to visit the Palace of Holyrood and the abbey. The abbey dates from around 1128, and the palace from the 16th century. The English burned the abbey in 1544, and Bonnie Prince Charles resided there in 1745. Today, Holyrood House is the Edinburgh official residence of the British Royal Family. After our castle visit, continue to "The Scotch Whiskey Experience" for a whiskey tasting tour. Learn how Scotch Whiskey is made and how distinct aromas are achieved. The tour ends with a "nosing" and tasting of your choice!

Dinner and overnight at our hotel in Edinburgh.

DAY 4 Tuesday, October 8: Edinburgh | Durham | York

Full Scottish breakfast at our hotel. This morning, we'll leave Edinburgh and drive south into England, passing through the border country with its several ruined abbeys, each standing as testimony to King Henry VIII's dissolution policy in the 1540s following his bitter feud with the Catholic Church. Late morning we'll arrive in the historic city of Durham. We can trace Durham's history back 1,000 years to the arrival of a religious community seeking a permanent resting place for the body of St. Cuthbert of Lindisfarne. As a shrine for their saint, they built first a wooden, then a stone, church on top of a rocky hill, protected on three sides by the River Wear. The community of Cuthbert gave way to Benedictine Monks and a Bishop appointed by the king. The Venerable Bede's bones have been in Durham Cathedral since 1022. They were brought from Jarrow by a monk called Alfred who had them buried alongside Cuthbert's relics at Durham Cathedral. St. Bede the Venerable (d. 735) is called "The Father of English History" due to his authorship of "Ecclesiastical History of the English People." In 1899 Pope Leo XIII declared him a Doctor of the Church. Durham is dominated by the Norman Cathedral, which overlooks the city from atop a great hill. The cathedral is of great architectural significance and historians from all over the world visit to study its

style. Independent lunch. Free time to explore Durham on your own.

This afternoon we'll visit Durham Castle, which has been occupied since 1837 by University College. Late afternoon, we'll continue to the city of York for hotel check-in.

Dinner and overnight at our hotel in York.

DAY 5 Wednesday, October 9: York

English breakfast at our hotel. This morning, begin our day with a visit to York Minster Cathedral, claimed to be the largest Gothic Cathedral north of the Alps. In fact, these windows combine to create the largest single surviving collection of Medieval stained glass in England. Its unusual, octagonal Chapter House has a late 15th-century choir screen by William Hyndeley. Possible lunchtime performance at York Minster Cathedral. Independent lunch.

Enjoy a brief walking tour through a section of the famous York City Walls, which encircle the entire city and are more miles than any other in England. The city of York was built by Romans and later occupied by both Vikings and Anglo-Saxons. A visit to the York Museum will reveal much of the exciting history of the city, and the Museum Gardens are known for their beauty. York is also famously known as "The Chocolate City." Visit York's Chocolate Story on Kings Square to learn the story and purchase some delicious sweets. Or stop in at Monk Bar Chocolatiers in the Shambles for some very original chocolate sculptures. Dinner and overnight at our hotel in York.

DAY 6 Thursday, October 10: Stratford | Oxford

English breakfast at our hotel. This morning we'll leave York for Stratford-upon-Avon. Enjoy a half-day sightseeing tour of this charming market town on the river Avon, famous for its connections with Britain's most notorious playwright, William Shakespeare. A tour of the town will bring to life many of the sites associated with Shakespeare, including the house on Henley Street where he was born, which is now a museum dedicated to his life and works. See the thatched cottage that was the family home of his wife, Anne Hathaway. Possible performance at a local community in Stratford. Independent lunch.

We'll continue to Oxford through the picturesque Cotswolds. Check-in at our hotel.

Dinner and overnight at our hotel in Oxford.

DAY 7 Friday, October 11: Oxford | Windsor Castle | London

English breakfast at our hotel. After breakfast we will meet our guide for a walking tour of Oxford, including Trinity College, Christ Church Cathedral and the exterior of Oriole College. Independent lunch.

We'll leave Oxford for London, with a stop to visit Royal Windsor and tour the town. Visits include the royal state apartments within the castle and St. George's Chapel. Continue to London for hotel check-in.

Independent dinner. Overnight at our hotel in London.

DAY 8 Saturday, October 12: Highlights of London

Gala dinner at a restaurant. Overnight at our hotel in London.

English breakfast at our hotel. This morning, enjoy an orientation tour of London, passing the Houses of Parliament, Big Ben, Trafalgar Square, Nelson's Column, Piccadilly Circus, and the London Eye. Continue to the Mall and Buckingham Palace, where the Changing of the Guard takes place daily. Independent lunch. We'll visit St. Paul's Cathedral, seat of the Bishop of London, and the Tower of London. Visit the Chapel Royal of St. Peter ad Vinicula, the parish church of the Tower of London and burial place of St. Thomas More and St. John Fisher. Continue to visit the Church of the Immaculate Conception, Mayfair Farm Street. Evening concert at the Immaculate Conception Church, Mayfair Farm Street.

DAY 9 Sunday, October 13: Stonehenge, Old Sarum, and Salisbury <u>Cathedral</u>

English breakfast at our hotel. Today we'll leave London and drive through Royal Berkshire and the sweeping Salisbury Plain toward Stonehenge. Here lies Old Sarum, the original site of Salisbury. For more than 4,000 years it served as a fortress and religious site, from a Neolithic henge and fort to a Norman castle and cathedral. The site was abandoned in 1219 when the bishops moved to "New Sarum," or Salisbury. See the historic and mysterious Stonehenge, Britain's most famous prehistoric monument. Independent lunch.

We'll continue to visit the magnificent Salisbury Cathedral, with its majestically elegant spire (the tallest in England) rising above the water meadows beside the Avon River. Return to London. Independent dinner.

DAY 10 Monday, October 14: Return to the USA

Overnight at our hotel in London.

English breakfast at our hotel. Late morning, we'll be transferred to London Heathrow Airport for our return flight to the USA.

This pilgrimage entails a lot of walking, stairs, hills, cobblestone roads, etc. Participants must be medically and physically fit for this type of travel Package inclusions do not always meet the special needs of travelers with limited mobility or severe allergies.
